



Rules & Regulations

1. The competition is open to producers, customers and designers of products made with one of the Eska board products.
2. Each entry must include the following:
 - the physical product
 - name of the producer
 - name of the customer
 - name of the designer (if any)
 - production date
 - number of copies produced
 - contact person and contact data for the competition (name company, contact person, address, telephone number and e-mail address).
3. All products must be present at one of Eska Graphic Board's locations before 2 April 2012 (see enclosure).
4. All products submitted must be made with one of the Eska board products.
5. Eska Graphic Board will assign the contributions to a region, based on the place of business or residence of the entrant, and product category.

There are 5 regions:

 - Southern Europe (incl. France)/Latin America
 - Northern, Western and Eastern Europe
 - USA/Canada
 - Asia/Australia/New Zealand
 - Middle East/Africa

There are 4 product categories:

 - Books
 - Stationery
 - Puzzles and games
 - Displays and luxury packaging
6. All participants to the competition will receive an acknowledgement of the receipt of their contribution by e-mail.
7. Entrants consent to the use of their submitted products for promotional purposes by Eska Graphic Board. Entrants indemnify Eska Graphic Board and hold Eska Graphic Board harmless from and against any copyright claims from third parties.
8. Submitted products will not be returned to the entrant. Eska Graphic Board is not responsible for late, lost, damaged, misdirected, postage due, stolen or misappropriated entries.
9. The jury will be appointed by Eska Graphic Board B.V. The choice of the jury is binding. No correspondence, disputes or alike will be admitted with regard to the results.
10. Products will be judged according to the following criteria:
 - creativity
 - originality
 - craftsmanship
11. The best product in each product category in each region will be rewarded with 500 Euros. The winners of these money prizes will compete for the Frog Award in their product category. There is a Frog Award for each product category.
12. The prize winners will be announced on the Eska Graphic Board website in May 2012 and they will be contacted personally. The money prizes will be transferred to the entrants in May 2012. The Frog Awards will be presented in consultation with the winners.
13. In cases where these rules and regulations do not suffice, Eska Graphic Board will make a binding decision.
14. Entrants are acquainted with these rules and regulations and agree to be bound by all terms of these rules and regulations.
